HexaCorp Privacy Policy

HexaCorp is an Information Technology Solutions and Services company offering On-Site Services, Managed Project Solutions, Off-Shore Development and Support Services, Project Management, Consulting Services and execution of Fixed bid Assignments to clients across the United States and Canada. We strive to provide our customers with the best Products and Services available and recognize the fact that building a long-term business relationship with you depends a great deal on trust. This trust begins with our commitment to respecting as well as protecting your privacy and in furtherance of this goal HexaCorp acknowledges that it respects the privacy rights of its Customers and will comply with all applicable privacy laws in the countries in which HexaCorp does business.

We have structured our website so that, you can visit HexaCorp on the web without identifying yourself or revealing any personal information. Once you choose to provide us personally identifiable information (name, address, e-mail address, phone number, etc.) you can be assured that this information will only be used to facilitate and support your communications with HexaCorp. Our RFP process or Sales Engagement process may request and/or require you to submit business related information. Any personal information shared with HexaCorp will be protected by industry standard security and management procedures and will be used only for the purpose for which it was submitted, unless you request or agree otherwise.

Our privacy statement explains how we protect the information of visitors and customers gathered via our webpages and covers five main areas: Awareness, Choice, Access & Correction, Security and Additional Web Site Issues.

1. Awareness

HexaCorp provides this Privacy Policy to make you aware of our privacy practices and of the choices you can make about the way your information is collected and used. This Privacy Statement may be supplemented or amended from time to time by Privacy Statements that are specific to certain areas of this website (e.g., web apps products). If you have any questions or concerns regarding this Privacy Statement, please contact webmaster services using the <u>contact us</u> link.

What Information We Collect

As a visitor, you are not required to submit any personal information in order to use the website. This website collects personal information only if it is specifically and voluntarily provided by the visitors. Such information may consist of, but is not limited to, your name, current job title, company address, email telephone and fax numbers.

This Website may also collect content which you are willing to provide, including but not limited to postings on any blogs, forums, wikis and other social media applications and services that we may provide.

We do not seek confidential information (e.g., data relating to race or ethnic origin, religious beliefs, criminal record, physical or mental health or sexual orientation) from visitors. We will, where necessary, obtain your explicit consent to collect and use such information.

In order to tailor our subsequent communications to you and continuously improve our products and services, we may also ask you to provide us with information regarding your personal or professional interests, demographics, experience with our products and contact preferences.

Information Collected Through Technology

When you use our web site or services, we or our service providers may collect tracking information such as your browser type, mobile device, the type of operating system you use, the domain name of your Internet service provider and pages visited on the web sites. We use this information for aggregate reporting. For example, we may choose to find out how much time the average visitor spends browsing on our web sites or which pages or features get the most attention. We use this information to make our web sites and other products and services more useful to you; to provide you with more effective customer service; to make the web sites or services easier to use by eliminating the need for you to repeatedly enter the same information; to perform research and analysis aimed at improving our products, services and technologies; and to display content and advertising that are customized to your interests and preferences. How We Use the Information

HexaCorp uses your information to better understand your needs and provide you with better service. At times, you may choose to submit personal information on the HexaCorp site, e.g., to gain access to specific content, respond to a survey or request communications about specific areas of interest. In such cases, the information you submit may be used to manage your request; to manage our relationship with you; or to customize or improve our Website.

Data processing related to the services offered on this web site is done at the company headquarters or its offshore locations outside the US and accessed only by employees, direct HexaCorp collaborators or partners, or other professionals / companies assigned with occasional maintenance / upgrade jobs. No personal data derived from web services will be transferred to a third party or made public. The personal data provided by the user who required a service, is used with the aim of carrying out the service or allowing the required access, or used with the purpose of serving the general business activities of HexaCorp. It is not disclosed to third parties, unless disclosure is required by law or necessary for the fulfillment of the requests.

From time to time, we may also contact you for market research purposes or to provide you with marketing information or to send you promotional materials or communications regarding services provided by us which we think would be of particular interest to you . We may also contact you to seek feedback on our services or for market research purposes. Your personal information may also be used to protect our rights or property and that of our visitors. HexaCorp will not reveal your personal information publicly or to any third party (except as stated below), unless we receive your explicit permission to do so. Your name will not be used for any such purpose unless you expressly request HexaCorp to do so. You may at any time request that we discontinue sending you emails or other communications generated in response to your registration on this Website.

The types of processing data may include:

a) Navigation Data:

When you visit our Web site, our Web server makes a temporary record of each access and stores it in a log file. The following data is recorded and stored with an automatic deletion date:

- IP address of the requesting processor
- Date and time of access
- Name and URL of the downloaded file
- Volume of data transmitted
- Indication whether download was successful.
- Data identifying the browser software and operating system
- Web site from which our site was accessed
- Name of your Internet service provider

The purpose of recording these data is to allow use of the Web site, for system security, for technical administration of the network infrastructure and in order to optimize our Internet service. The IP address is only evaluated in the event of fraudulent access to the network infrastructure of the HexaCorp.

Apart from the special cases cited above, we do not process personal data without first obtaining your explicit consent to do so.

b) Personal data

Personal data is collected, stored, used, and transferred only for the specific purposes mentioned in the privacy policy.

All and any use of your personal data is confined to the purposes stated above, and is only undertaken to the extent necessary for these purposes. Your data is not disclosed to third parties. Personal data will not be transferred to government bodies or public authorities, except in order to comply with mandatory legislation or if the transfer of such data should be necessary in order to take legal action in cases of fraudulent access to our network infrastructure. Personal data will not be transferred for any other purpose.

c) Data provided voluntarily by the visitor

Optional, explicit and voluntary mailing to the addresses listed on this site involves the following acquisition of sender e-mail address, necessary to respond to requests, as well as any other required and voluntarily data provided by the user. We encourage our web visitors, whenever they require services or have questions, to avoid sending names or other personal data involving any third party, except where this is strictly necessary.

With Whom We Share the Information

HexaCorp will not sell, rent, or lease your personally identifiable information to others without your permission. Unless we have your permission or are required by law, we will only share the personal

Such HexaCorp entities and/or Business partners are governed by our privacy policies with respect to the use of this data and are bound by this Privacy Policy and applicable confidentiality agreements.

2. Choice

In addition to what is specified for the navigation data, you are free to provide personal information to request sending you advertising material as well as other services offered by HexaCorp, simply, to get in contact with HexaCorp. The partial, incomplete, or incorrect sending of such data may result in experiencing difficulty for you to obtain the requested services or materials. Visitors of our website who provide their own data to gain access to the services offered through the web accept to be contacted directly by the HexaCorp staff members who have been authorized by the company, in agreement with the commercial objectives of the company. To protect your privacy and security, we will also take reasonable steps to verify your identity before granting you access or enabling you to make corrections. Visitors who have any problem accessing, or would like to request a copy of their personal information should contact our web services team using the contact us link. In all cases we will treat requests to access or change information in accordance with applicable legal requirements.

4. Security

HexaCorp's website collects standard Internet log information including your IP address, browser type and language, access times and referring website addresses. To ensure that our website is well managed and to facilitate improved navigation, we or our service provider(s) may also use cookies (small text files stored in a visitor's browser) to collect aggregate data. We or our service providers may use these technical methods to analyze the traffic patterns on our web sites, such as the frequency with which our visitors visit various parts of our web sites and to measure site effectiveness or use of online products and services. On their own, cookies do not contain or reveal any personally identifiable information. However, if you choose to furnish HexaCorp with personally identifiable information, this information can be associated to the data stored in the cookies. These technical methods may involve the transmission of information either directly to us or to our service providers. These technical methods allow us to make our web sites and other products and services, and any emails you have agreed to receive, more interesting and meaningful to you.

HexaCorp also uses cookies to store, and sometimes to track visitor information. International Data Transfers

Accordingly, Candidate Data may be transferred to and processed in the US and other countries that may not be deemed to provide the same level of data protection as your home country. HexaCorp maintains and applies employment data protection standards consistent with those specified in this Policy to its operations globally.

Sensitive Candidate Data

HexaCorp may perform background and criminal checks where permitted by law, and may process other Sensitive Candidate Data, such as citizenship or nationality information or health information, when relevant for a position and as permitted by law. If HexaCorp intends to collect Sensitive Personal Data from third parties, you will be provided notice and the opportunity to consent. If you have a disability and would like HexaCorp to consider an accommodation, you may provide that information
